PURPOSE

The purpose of this addendum is to extend the termination date of the original contract, as amended, from June 30, 2015, to June 30, 2016. The terms and services of the agreement remain unchanged, except for the following:

1. The scope of duties is expanded to include additions made in previous addenda extending the original contract through June 13, 2014; and
2. The charges under paragraph 6.2 of the contract shall be based on the current hourly fee scheduled (Exhibit A) with the 15% discount applied.
